Fill the tank with hand hot water (max 40°C) to the level indicated. Now use your vacuum washer following the manufacturer's instructions. Do not overwet carpet. For best results vacuum the carpet when dry. **Safe for use on all carpet types including pure wool.** Suitable for use on upholstery. Check upholstery manufacturer's washing guidelines. Always test on a hidden area for colour fastness.
